Customs Brokers License Management System (CBLMS)

<u>User Manual – Application for Surrender of CB License on CBLMS Portal</u>

With the introduction of new functionalities in CBLMS, the CBs can process application for Renewal of INVALID License on CBLMS portal. The process of apply through CBLMS, is explained below:

1: LOGIN :

- a. The applicant needs to login into the portal.
- b. On clicking the login button on the homepage, the following page will be displayed.



- i. Username i.e PAN card of the Customs Broker
- ii. Password
- iii. Press Log In button after entering the Username and Password to log into the account.

c. After clicking on the "Log In" button, an OTP will be sent via SMS to the registered mobile number of the applicant and the following OTP page will be shown

- i. Enter the 6-digit OTP as received on the registered mobile number of the Customs Broker.
- ii. Click on the Confirm button to confirm the login.

2. **APPLICATION:**

a. On successful login into the portal, the following screen will appear. Click on the "Application form" Menu as highlighted below for initiating the process of Application for Renewal of INVALID License.



b. On clicking the "Application Form" button, drop down list will be displayed wherein the CB needs to select "Application for Renewal of INVALID License" menu as highlighted below.

i. **Parent Policy Section:** The CB needs to select the parent policy section from the drop-down list.

After filling the above mentioned detail, the CB needs click on the following checkbox as *Yes or No*:

- Do you have any dues Pending to the Central Government under the Provisions of the Customs Act, 1962 (52 of 1962), the Integrated Goods and Service Tax Act, 2017 (13 of 2017), and the Finance Act, 1994. Rules or Regulations made there-under.
- Whether Bond and Furnishing of Security Executed Under regulation 8 is still Active
- Is There A Change in the Name and Permanent Account Numbers (PAN) of Partner/Partners Or Director/Directors who will actually be engaged in the work as Customs Broker, in case the applicant is a firm or a Company.

ii. **Reason For Renewal:** The CB needs to mention the reason for renewal of INVALID License.

iii. **Upload Any Other Relevant Document:** Any other relevant document that needs to be uploaded along with the above details regarding the employee (*only pdf file, max. 10MB*).

After filling the above mentioned detail, the CB needs click on the following checkbox as *Yes or No*:

- I have Working Knowledge of English
- I have Working Knowledge of Hindi
