Sub: Conduct of G-category examination for the year 2023 under Regulation 13 of CBLR, 2018 by Mumbai Customs Commissionerate- Reg.


Kind attention of **all Authorized Couriers and their employees** is invited to Public Notice no. 04/2023 dated 18.04.2023 on the above referred subject. The employees of Authorized Couriers issued valid ID Card on or before 18.04.2023 are eligible to appear in the aforesaid examination. Only four attempts are allowed from the date of appointment as employee of Authorized Courier.

2. In this regard, the desirous employees of Authorized Couriers (duly approved by Dy./Asstt. Commissioner of Customs) who wish to apply for the G-category examination scheduled to be held on 21.05.2023 may apply for the same through offline mode (Sevottam counter) from 24.04.2023 till 10.05.2023 (6 PM) in the format as annexed to this Addendum.

3. After scrutiny of the applications, a list of eligible candidates will be displayed on or before 12.05.2023 on the website www.mumbaicustomszone1.gov.in. Admit cards containing the details of venue, examination date & time to the eligible candidates will be issued manually on 18.05.2023. Candidates are informed that they will have to attend this office for collection of their respective admit cards.

4. All the eligible candidates shall bring their Hall Ticket, Aadhar Card and ID card of the Authorized Courier agent on the examination date to their respective examination centres, failing which they shall not be permitted to appear in the examination.

5. Further, all other criteria such as payment of fees, examination mode, details, pattern, advisory for applicants for use of unfair means and mis-statement of information etc. will remain same as far as applicable as mentioned in Public Notice no. 04/2023 dated 18.04.2023.
