**PUBLIC NOTICE NO.: 11/2023**

**Sub: Conduct of G-category examination for the year 2023 under Regulation 13 of CBLR, 2018 by Mumbai Customs Commissionerate-Reg.**

Kind attention of all the stakeholders is invited to Public Notice Nos. 04/2023 dated 18.04.2023, 08/2023 dated 24.04.2023 and 10/2023 dated 03.05.2023 on the above referred subject.

2. In this regard, it has been observed that a large number of applicants are not uploading the **'Self-Declaration on the number of attempts'** which as per Issue No. 04 of PN 08/2023 was to be uploaded in "Any Other Relevant Document" field. Further attention is invited to PN 04/2023 and PN 08/2023 wherein it was stated that applicants must ensure correctness/completeness of details filed and that incomplete/incorrect applications shall be summarily rejected.

3. However, considering that the applicants are getting a chance to appear in G - Category examination after a long gap of 05 years, and taking a sympathetic view, one last chance is being given to applicants to send the same on email id [cbsec.nch@gov.in](mailto:cbsec.nch@gov.in) latest by 12.05.2023 (06:00 PM) clearly specifying their CBLMS application number in the e-mail/self-declaration certificate, failing which their application for G-card examination will be rejected as already envisaged in Public Notice No. 04/2023 dated 18.04.2023.

4. Further it has been observed that many applicants have uploaded **photos and signatures that are not legible**. In order to cross-verify their current appearances with AADHAAR card, all applicants **shall carry 2**

**printed copies of the same photographs as uploaded on CBLMS** along with their Admit Card and AADHAAR Card at the venue of examination.

5. Moreover, as last date of submission of applications has been extended till 10.05.2023, and list of eligible candidates was to be displayed on or before 12.05.2023, the same shall now be displayed on or before 17.05.2023. This shall apply to applicants who are employees of Authorised Courier as well.
