- The attention of all Importers, Exporters, Customs Brokers, and other stakeholders actively engaged in operations within the jurisdiction overseen by Bengaluru Customs, is hereby directed to the recent introduction of a new functionality called as the "Self-Customs Pass for Importer/Exporter" on the Customs Brokers Licensing Management System (CBLMS) online portal (<a href="https://cblms.gov.in">https://cblms.gov.in</a>).
- 2. The newly introduced functionality, "Self-Customs Pass for Importer/Exporter," is specifically designed for utilization by (a) importers or exporters engaged in conducting business exclusively on their own account at a Customs Station, and (b) employees of individuals or firms conducting business generally on behalf of such individuals or firms, who possess a valid identity card or temporary pass issued by the Deputy Commissioner of Customs or Assistant Commissioner of Customs, as applicable.
- 3. To facilitate a seamless understanding of the operational procedures associated with this feature, a comprehensive User Manual outlining the process flow has been made accessible
