ADDENDUM TO FACILITY CIRCULAR NO. 11 /2024 DT. 12.12.2024

विषय: चेन्नई सीमा शुल्क आयुक्तालय द्वारा सीबीएलआर, 2018 के विनियमन 13 के तहत वर्ष 2024 के लिए जी-श्रेणी परीक्षा का संचालन

Sub: Conduct of G-category examination for the year 2024 under Regulation 13 of CBLR, 2018 by Chennai Customs Commissionerate Reg.

Kind attention is invited to the Facility Circular no. 11/20241 dt. 12.12.2024 issued by this office on the above mentioned subject.

In this regard, following is added in respect of Authorized Couriers

2.Eligibility Criteria for Authorized Couriers :

An employee of Authorized Couriers (duly approved by Dy./Asst. Commissioner of Customs) having a valid ID Card issued on or before 01.12.2024 are eligible to appear in the aforesaid examination. Only four attempts are allowed from the date of appointment as an employee in any Authorized Courier. A declaration to this effect with regard to the number of attempts earlier made, if any, may be given.

3. Mode of Application for Authorized Couriers:

The application has to be submitted in offline mode either by hand or through speed post from 27.12.2024 till 07.01.2025 (by 06.00 pm) in the format enclosed as Annexure-A. In case of Registered/ Speed post the application should be sent to "The Assistant Commissioner of Customs, Customs Broker Section, 4th Floor, Custom House, Chennai - 600001" and in case of delivery by hand it must be submitted in Sevottam Section, Ground Floor, Custom House, Chennai- 600001. Applications sent by post after the deadline will not be considered.

4. A list of eligible candidates will be displayed on or before 21.01.2025 on the website

<https://chennaicustoms.gov.in/> and also vide a Public Notice. Admit cards containing the details of venue, mode of exam, examination date & time to the eligible candidates will be issued manually from 27.01.2025 to 02.02.2025 (excluding holidays) between 10am to 6pm. The eligible candidates either in person or through their duly authorized person along with a photo identity card will have to visit Customs Broker Section, 4th Floor, Custom House, Chennai – 600001 to collect the respective admit card during the said period. No admit card will be issued after the prescribed period.

This is issued with the approval of the Pr. Commissioner of Customs, General Commissionerate, Chennai Customs.
